**Q: Who can register for this competition?**

**A:** The competition is open to all undergraduates based in Singapore and Hong Kong. Full-time postgraduate students from local universities, colleges or institutes of vocational education etc., are not eligible to enter the competition.

**Q: How many people make up one team?**

**A:** Each team must consist of four members to be able to participate. Unfortunately, we are not able to find a team for individual sign-ups.

**Q: Can I team up with participants from other universities?**

**A:** Yes, your team can include students from different universities within Singapore & Hong Kong. However, teams with members from both territories are not allowed.

**Q: Can we change the team members during the competition?**

**A:** The changing of team members is not allowed once the cases are released. If a registered team member has an emergency that precludes him/her from participating, teams can still participate with the remaining members.

**Q: What happens if I have registered but I can no longer submit the case solution by the given deadline? Can the submission deadline be postponed?**

**A:** The deadline for the case submission is fixed and it is based on Singapore/Hong Kong time zone (GMT+8). Should the team have a conflicting schedule, we regret to say that our deadline cannot be postponed for the fairness of the competition.
